## A MESSAGE FROM THE **EXECUTIVE DIRECTOR**

If our journey to reopen our cottages was a chapter book, the first chapter might be the longest, most tedious, circuitous, and frustrating chapter in the book. After three and a half years and four separate submissions of documents, in November we finally received permission from the Department of Health Construction Review Services (DoH – CRS) to move forward with somewhat minor building modifications that must be done to comply with licensing requirements. Unfortunately, although it may involve other twists and turns in the plot, this chapter could be written by many other agencies in this State. This first step in obtaining a Residential Treatment Facility (RTF) License is arduous in the State of Washington.

We are on to a new chapter that has wonderful surprises and a lot of activity. An angel donor provided Ryther with a gift that covers all the building modification expenses for each of the three cottages! It is an extraordinary gift to Ryther and to the community that needs the residential treatment services we will be opening. We have a wonderful project manager who is working with the contractors to complete the required work as quickly as possible. When the work is completed, the cottages will be refreshed and available to children and youth who need this scarce level of care. However, I am getting ahead of myself and skipping to the end of the book. There are several other chapters to go that include final approval of the construction work by the DoH, an approval by the State's Fire Marshal, and approval of our policies and procedures by DoH.

While we look forward to finishing this book, we continue to move on with our other "stories" – opening our co-occurring intensive outpatient program for youth with both mental health and a substance use concerns, restarting our dialectical behavioral intensive outpatient program for youth with behaviors that interfere with important parts of their lives, and initiating a partial hospitalization program for young people struggling with eating disorders. We could not have "written this book" without the support of the community. We thank you for being an essential part of helping us begin these critically needed services and continue the programs we provide to over 2,000 young people each year.
